AS AN APPLICANT FOR A PERMIT TO PURCHASE A PISTOL OR FOR REPORTING THE TRANSFER OF A HANDGUN, YOU ARE BEING ASKED TO PROVIDE PRIVATE DATA ABOUT YOURSELF THAT WILL BE USED TO CHECK VARIOUS DATABASES TO DETERMINE YOUR ELIGIBILITY TO LAWFULLY ACQUIRE A FIREARM. AUTHORIZED RECORDS WILL BE EXAMINED TO EXECUTE A BACKGROUND CHECK AND DETERMINE IF APPLICANT IS PROHIBITED BY STATE OR FEDERAL LAW FROM PURCHASING A FIREARM.
